The OPEN and JUNIOR class competitors will first play an air, followed by a pause. Then the competitor will play, without pausing between tunes, a march, a strathspey and a reel, in that order. NOVICE class competitors will play three tunes, either (a) an air, followed by a pause, then without pausing between tunes, a strathspey and a reel; or (b) a march, strathspey and a reel played without pausing between tunes.

### GENERAL RULES AND REGULATIONS

1. The FIDDLEING COMPETITION will be conducted in accordance with guidelines established by Scottish FIRE. For further information, go to [www.scottishfiddling.org](http://www.scottishfiddling.org).
2. Each competitor must pre-register and check in at the Scottish Fiddling Tent by 9:45am.
3. First, second, and third place medals will be awarded in all events.
4. Order of competition in each class will be determined by date of receipt of entry form. First received will perform last, last received will compete first.
5. Entry fee includes a Competitor's Pass for the Festival-Games.
